The Animal Encounters Barn is an interactive facility allowing visitors to meet and interact with farm animals. The Farm Park Supervisor will lead a team of Assistants delivering engagement activities and interpretation about the animals and their husbandry both in the Barn and in the outdoor paddocks.
